Customer grants to ADT or its independent contractors the right to examine its books, records and accounts during Customer's normal business hours to verify compliance with the above provisions. In the event such audit discloses that this Software is utilized with a third party company's hardware product or in violation of United States FAR or Export ITAR regulations, Customer shall promptly halt the use of respective ADT Software and said third party hardware product and pay ADT a fee equal to the retail price of the equivalent ADT product (hardware or Software).
